### **BACKGROUND INFORMATION:**

- Short Term Rentals growth in our City from 5 to 29 units in the last 5 years
- 99.9% of STRs do not pay taxes
- Gap in Hotel Occupancy Tax Revenue collected by the City
- Lack of resources to monitor STR's
- The cost for these services will be absorbed by the additional revenues generated, although the finance department has about \$50,000 remaining in the current budget for professional fees.
- Insight was selected over Granicus (although it was cheaper) due to the full suite service they provided and the implementation time was shorter.

Potential revenue increase of \$89,000 at 40% Occupancy- minus the 15K - remaining \$74,000
